### **Chievo Verona Football Camp - Day & Eve formula only**

It is a typical Camp without staying overnight, for participants who can reach easily the site of the camp every day. The subscription cost of the week camp includes 12 hours of technical classes over 3 days (Fri to Sun) during the hours advertised, and one (1) official kit – Chievo School.

### **Booking**

Responsibility for the details of bookings and for payments lies with the person making the initial booking and this person must be over 18 years of age.

### **Confirmation and Payment**

Your booking will be confirmed after we receive your booking form fully completed and the appropriate payment. Payment is regarded as your acceptance of the booking conditions and is non-refundable. If full payment is not received by final payment due date, Prime Language Courses reserves the right to refuse entry to the course. Payment can be made by, bank transfer direct to Prime Language Courses or directly to your nursery.

### **Administration Charge**

Please note, we reserve the right to levy an administration charge of Eur 50 in respect of any changes made to the booking details after the initial booking has been confirmed.

### **Health Certificate**

Please provide together with this application-form a **medical certificate (Family Doctor's Clean Bill of Health)** stating your good health conditions. (suitability for not agonistic gymnastic-motor activities medical certification). Nobody will be admitted to the camp without the Health Certificate.

### **Medical Information**

If a participant is under medical treatment during the camp, it is strongly recommended to send with your registration a copy of the treatment being followed by the participant. It is strongly recommended to mention all allergies on the Registration form within the NOTE section..

### **Relief from Responsibility and Damages**

I furthermore declare to relieve PRIME LANGUAGE COURSES and any member of its staff or appointed person from any responsibility for damages that the camper/child should cause during the stage of the Chievo Verona Football Camp. In any case should damages occur to premises they will be charged to the camper/child who will be found responsible for them.

### **Cancellation**

If you wish to cancel your Chievo Verona course, for whatever reason, the full amount will be retained to cover costs and will not be refunded. Alternatively, you can search for another person to substitute you for the camp.

No compensation will be paid or refund given if cancellation or change by the company is brought about by war, strikes, technical problems with transportation, weather or any other event outside the control of the company or because of low uptake.

### **Negligence**

Prime Language Courses accepts responsibility for those elements of the course under our direct control if caused by proven negligence of the company or its employees. We cannot accept responsibility for the loss of enjoyment due to the following factors: travel arrangements, strikes, bad weather, personal injury or illness suffered whilst on the course, including when we use sub-contractors such as transportation companies.

### **Program Changes**

- Be a good sport. Always encourage fellow squad members.
- Respect your own and other people's property.
- Control your temper. Make no criticism either by word or by gesture.

### As a guest:-

- Observe common courtesies at all times.
- Respect the conventions and cultural norms of the countries in which we are touring.

### Dress:-

- Always maintain a neat and tidy appearance.
- Your GIVOVA Chievo Verona Football Camp kit shall be worn during the all moments of the Chievo Verona Football Camp.
- Wear your uniform with pride.

### Welfare:-

- The safety and welfare of players attending the Chievo Verona Football Camp is paramount and while the direct responsibility falls onto the shoulders of the Chievo Verona Football Camp staff, all players should be aware and assist all members of the Chievo Verona Football Camp.
